Accommodation rules

The operation of the accommodation facility, safety and fire protection in the accommodation facility is always the responsibility of the manager. Responsibility for the accommodation facility can only be assumed based on a written authorisation. Residents are always obliged to obey the instructions or orders of the accommodation operator for safety reasons.

Before moving into the accommodation facility, the guest must present a document (valid ID card, passport or other valid ID) to prove his/her identity and to register in the guest book (registration card). The use of the accommodation is only allowed for persons who are not affected by infectious or other communicable diseases. Payment for accommodation and other services is subject to the operator's billing and cancellation policy.

The accommodation establishment is not responsible for any items, money or valuable items placed in the rooms or in the premises of the Starý svět, zájezdní hostinec, s.r.o.

Guests are responsible for locking their rooms.

The last person to leave the room must turn off the light and check the bathroom for water leaks.

Basic instructions for the guests

- a) In all areas of the accommodation facility, including outdoor areas is smoking forbidden (including the rooms and restaurant).
- b) Responsibility for minors lies with their parents or guardians or people authorized by legal guardians. The same responsibility also applies to owners of pets who are accommodated with their owners in the Starý svět zájezdní hostinec.
- c) It is forbidden to light any fire or use any pyrotechnics in the accommodation premises.
- d) It is forbidden to run inside the accommodation, especially on the stairs.
- e) It is forbidden to climb out of the windows, climb down the staircase railing and jump on the staircase.
- f) It is forbidden to throw cigarette butts alternatively burning or fuming matches or other objects into the trash.
- g) Any damage to the accommodation must be reported to the owner, manager or to the operator.
- h) The guests are obliged to familiarize themselves with the fire protection documentation, which is posted in the rooms and corridors of the accommodation.
- i) All equipment located in the rooms must be used in the usual and customary manner to their determination.
- j) Other activities not listed in the Rules of Operation are necessary to discuss with the owner or manager of the accommodation facility, alternatively with the staff.
- k) In case of any doubt are guests obligated to ask the staff of the accommodation facility for explanation of the function of a certain gear and explanation of its operation.
- l) The owner of the accommodation facility warns the guests that they are not alone and therefore it is necessary to adjust their behaviour to avoid conflict situations.
- m) Residents are required to observe nighttime quiet from 22:00 to 6:00 inside and outside the building. The responsibility for compliance with this obligation rests solely with the residents.
- n) Residents are obliged to refrain from any behaviour that would restrict other residents of the village in their rights, especially by noise, restricting access to their land by parking vehicles, or entering the surrounding private land.
- o) Operator Starý svět, zájezdní hostinec, s.r.o. shall not be liable for any injury or damage caused by the guests by violation of this accommodation rules and other rules posted by the operator.
